The Beaufort-Jasper Water and Sewer Authority will open sealed Bids at 2:00 p.m., local time, on December 7, 2017 at Beaufort-Jasper Water and Sewer Authority, 6 Snake Road, Okatie, South Carolina for the Ladys Island Sewer Diversion Project.

A **mandatory pre-bid conference and site visit** will be conducted at 10:00 a.m., local time, on November 16, 2017 at Beaufort-Jasper Water and Sewer Authority, 6 Snake Road, Okatie, South Carolina. All Bidders are required to attend the Pre-Bid conference.

NOTE: FAILURE OF BIDDER TO ATTEND THE MANDATORY PRE-BID CONFERENCE WILL RESULT IN REJECTION OF THE BID.

Construction of the Ladys Island Sewer Diversion CIP-1767. The Project will be bid in two Divisions and consists of the following major elements. Award will be made to the lowest responsive and responsible Bidder(s). Bidders are not required to submit a bid for both divisions.

Division I – 16-inch Forcemain

- About 5,810 linear feet of 16-inch C905 DR21 PVC
- About 2,050 linear feet of 16-inch restrained joint ductile iron pipe
- About 90 feet of bore and jack crossing of road (30-inch casing)
- About 290 feet of fusible PVC HDD
- Appurtenances including fittings, fire hydrants, gate valves, air release valve assemblies
- Asphalt replacement and overlay, traffic control

Division II – SS01 Pump Station

- New self-priming centrifugal pump station (Gorman Rupp)
- Cast-in-place wetwell
- Floodproof cast-in-place structural concrete pump building with brick veneer and metal roofing
- Standby generator
- Associated electrical, instrumentation, HVAC, sitework, piping and demolition

Bidders must deposit security with all bids. Security shall be in the form of a certified check or bid bond made payable to the Owner, and shall be for an amount equal to not less than five percent (5%) of the amount of the bid. Provisions of the security shall be as described in the Information for Bidders.

No bid will be considered unless the bidder is legally qualified under the provisions of the South Carolina Contractor's Licensing Law (South Carolina Code of Laws as amended on April 1, 1999, Chapter 11, Sections 40-11-10 through 40-11-428).

No bidder may withdraw the bid within 90 days after the actual date of the bid opening. The Owner reserves the right to waive any informalities or to reject any or all bids.
